PUBLIC TRANSPORT COUNCIL ACT 1987

PUBLIC TRANSPORT COUNCIL (TICKET PAYMENT SERVICE LICENCE) (EXEMPTION) (AMENDMENT) ORDER 2026

In exercise of the powers conferred by section 70 of the Public Transport Council Act 1987, the Public Transport Council makes the following Order:

Citation and commencement

1. This Order is the Public Transport Council (Ticket Payment Service Licence) (Exemption) (Amendment) Order 2026 and comes into operation on 25 May 2026.

Amendment of Schedule

2. In the Public Transport Council (Ticket Payment Service Licence) (Exemption) Order 2014 (G.N. No. S 514/2014), in the Schedule —
